# Organization and University Partnership Preliminary Agreement \*

The purpose of this document is to setup a partnership preliminary agreement between the following Parties:

1. **Noorann Modern Education**, based in Redmond WA; Herein after referred to as “Organization”
2. **University**, based in CA; Herein after referred to as “University”

The Parties hereto agree as follows:

- i. Agreement shall start upon the awarding of the EIR grant CFDA Number 84.411 from the Department of Education to the Organization. Herein after referred to as “Project” [start 2021].
- ii. University pledges to spend the necessary efforts to support the project “Enabling students to learn critical language in private and public schools.” The University will help the Organization to achieve the goals, objectives, and measures during the Project period of five years.
- iii. Project objectives and outcomes for each year are explained in documents named project abstract, narrative, design, plan, and other supporting documents. The documents list the role of the University to help defining the education framework, creating the critical language content, developing the technology products, and deploying the project to schools in the United States.
- iv. University departments such as Education, Literatures, Cultures, Languages, and Computer Sciences shall support the Project and participate in the Organization education advisory boards.
- v. The University departments including staff, faculty, and students may contribute to the requirements as an assigned work item or as an academic research activity for up to 4000 hours.
- vi. Representatives shall work together to find the right resources at both sides, to setup monthly checkpoints to exchange requirements and contributions and to ensure a continuous productive partnership.
- vii. Parties agree to spend the utmost efforts to succeed the Project. Failure to fully collaborate on the project tenets and goals may result in agreement annulment with no obligations.
- viii. Parties can announce the partnership where applicable.
- ix. The Organization agrees to pay [x%] of the total amount of the grant to the University paid at the end of each year of the project.
